Historic Shareclass NAV Prices and Dividends	CSV/ Excel Template	A one-time Excel file with a historical record of Share Class NAV prices and dividends, either actual or synthetic. (The greater of 10 years or 5 years + the recommended holding period will be required.)

## Appendix III – Monitoring, Completeness & Control Reports

A Data Completeness Report is produced monthly showing whether an actual price was received for each weekday. Where a price is not received, it is either due to a pricing holiday, the price not being sent, or a class launch closure. As part of our service, we will review this and if prices are missing where it is not a pricing holiday, we will liaise with you/administrator to either source the price or understand why. Where needed we will source the missing data, load and re-run the calculations and the reports.

A **Controls Report** is produced monthly highlighting the following:

- Price to Price performance monitoring
- Observation count monitoring
- Month on Month Comparisons

A **Monitoring Report** is produced monthly highlighting the following:

- Comparison of the figures published in the PRIIPs KID and EPT.
- Colour coding to indicate:

A. Where a new PRIIPs KID is required due to a 5% difference from the RHP moderate performance scenario.

B. Where the latest calculation is different to the published PRIIPs KID/EPT for all other performance scenarios.
